Further, the Participant (or parent/guardian) releases and promises to indemnify, defend, and hold harmless Heart-Song Fellowship, its officers, agents, employees, and volunteers for any injury arising directly or indirectly out of the described Activity or transportation to, from and during the Activity, whether such injury arises out of the negligence of Heart-Song leaders, volunteers, any Participant, or otherwise.

If a dispute over this agreement or any claim for damages arises, the Participant (or parent/guardian) agrees to resolve the matter through a mutually acceptable alternative dispute resolution process. If the Participant (or parent/guardian) and Heart-Song Fellowship cannot agree upon such a process, the dispute will be submitted to a three-member arbitration panel for resolution pursuant to the rules of the American Arbitration Association.
